


## **Bentley Systems 2021 Greenhouse Gas Inventory**

Bentley is committed to environmental responsibility and aligning our business operations with the sustainable future our products enable. As part of our environmental policy, Bentley commits to measure and report our climate impact and to develop strategies to manage our climate impacts over time. In our second year of climate strategy, we continued to build upon our climate reporting by enhancing our scope of emissions calculations. Aligned with the GHG Protocol Corporate Accounting Standards, we assessed the 15 categories for Scope 3 emissions and aligned on eight relevant categories for our business. Working with a leading climate consultancy, we gathered activity metrics to construct our first complete Scope 3 GHG inventory. These results are detailed below and on the next page.

We also observed reductions in our direct (Scope 1 and 2) emissions compared to last year's (2020) inventory. These reductions were consistent on both an absolute and intensity basis. Please see the following pages for our previous year data.

Equipped with a complete inventory of our corporate climate impacts, we are assessing these insights to develop a long-term climate strategy aligned with leading global commitments. We are currently assessing the feasibility of setting science-based climate targets and ways to better manage our carbon footprint. We look forward to sharing our enhanced disclosures in the future and welcome any questions or comments regarding our current climate strategy.
